DEPARTMENT OF HOMELAND SECURITY ANNOUNCES THE FOURTEENTH ROUND OF THE FIRE PREVENTION AND SAFETY GRANTS AWARDING \$685,221 TO AID AMERICA'S FIRE DEPARTMENTS

(Washington, DC) April 28, 2006 – The U.S. Department of Homeland Security today announced the fourteenth round of the Fiscal Year 2005 Fire Prevention and Safety Grant Program (FP&S) awarding 6 grants to fire departments throughout the United States.

FP&S will issue approximately 400 awards worth at least \$32.5 million. The program prioritizes projects focusing on preventing fire-related injuries to children. Many of these awards represent innovative solutions for the delivery of fire prevention activities throughout the United States. In addition to these priorities, FP&S grants support research focusing on ways to improve the safety and health of firefighters.

“We recognize the importance of these grants in helping to keep our firefighters safe and healthy, and in curbing preventable fires from occurring in the first place,” said Tracy A. Henke, Assistant Secretary of the Office of Grants and Training (G&T).

This fourteenth round of grant awards provides \$685,221 to support fire prevention and safety efforts that focus on the safety of high-risk target groups, such as children, seniors, and firefighters. The organizations receiving awards in this round include:
